Haitong International Successfully Completed an Offshore USD Bond Deal for Tus-Holdings

Hong Kong, 27 November 2015 – Haitong International Securities Group Limited (“Haitong International”; Stock Code: 665.HK) is pleased to announce that it has completed an offshore USD bond deal for Tus-Holdings Co. Ltd (“Tus-Holdings”) with gross proceeds of USD 400 million on November 24. Haitong International acted as the Joint Lead Manager and Joint Bookrunner to assist the company in the bond deal and successfully raising funding from the debt market.

Tus-Holdings, set up in July 2000, is the former Tsinghua University Science Park (TusPark) Development Center founded in August 1994. Tus-Holdings is a large integrated enterprise established in reliance on Tsinghua University. It takes full responsibility for developing, constructing, operating and managing TusPark, and it’s one of the first National Demonstration Enterprises in modern service industry

Haitong International has already completed 20 debt issuance projects so far this year.
