**Haitong International Successfully Completed an IPO Deal for New Horizon Health**

**Hong Kong, 18 February, 2021** – Haitong International Securities Group Limited (“Haitong International”; 665.HK) has completed an IPO deal in Hong Kong for New Horizon Health Limited (“New Horizon Health”, 6606.HK), for which its corporate finance team and global capital market team acted as Joint Global Coordinator, Joint Bookrunner and Joint Lead Manager.

New Horizon Health focuses on the design, development and commercialization of cancer screening tests. According to Frost & Sullivan, ColoClear, New Horizon Health’s proprietary, non-invasive, multi-target, FIT-DNA test is the first and only molecular cancer screening test in China approved by NMPA. Shares of New Horizon Health were successfully listed on Hong Kong Stock Exchange today, closing at HKD 84, up 215.08% from its IPO price.

Haitong International has completed 6 IPOs in Hong Kong, 6 IPOs and 8 equity financing deals globally so far this year.
