Haitong International Named “Best Securities House of the Year” by Asiamoney

Hong Kong, 18 September 2018 – Haitong International Securities Group Limited (“Haitong International”, Stock Code: 665.HK) was named as the “Best Securities House of the Year – Hong Kong” in *Asiamoney Best Securities Houses Awards 2018* for the second consecutive year.

In the first half of 2018, Haitong International’s average daily trading volume recorded a y.o.y growth of approximately 50%. The company continues to upgrade its wealth management business, aiming to better serve clients with more diversified asset allocation solutions. As of 17 September 2018, Haitong International has completed 16 IPOs in Hong Kong and 22 equity financing deals globally this year. According to Bloomberg, Haitong International has completed 99 bond issuance projects by 17 September 2018, 50 of which are Asia (ex-Japan) G3 corporate high-yield bond projects. Haitong International ranked No.1 in terms of both number of deals and total underwriting amount in Bloomberg’s Asia (ex-Japan) G3 corporate high-yield bond underwriter league table.
