

## 通告 CIRCULAR

Subject: **Delisting of TIANJIN TROILA INFORMATION TECHNOLOGY CO.,LTD. (SSE Stock Code: 600225) (CCASS Stock Code: 90225)**

CCASS Participants are requested to note that TIANJIN TROILA INFORMATION TECHNOLOGY CO.,LTD. (SSE Stock Code: 600225) (CCASS Stock Code: 90225) (“TJ TROILA”) has issued an [announcement](#) (Chinese only) on Shanghai Stock Exchange (“SSE”) website. It states that the security will enter into a Delisting Arrangement Period (退市整理期) for 15 trading days (the “Delisting Arrangement Period”), i.e. the final period during which TJ TROILA shares can be traded on SSE before they are delisted from SSE.

The Delisting Arrangement Period will commence from 7 February 2025 and trading of TJ TROILA shares on SSE will be resumed on the same date. The Delisting Arrangement Period is currently expected to end on 27 February 2025. Afterwards, TJ TROILA shares will be delisted from SSE. TJ TROILA shares are Special China Connect Securities which are eligible for sell only in Northbound trading during the Delisting Arrangement Period.

**For any investor who wishes to sell any TJ TROILA share through China Connect Service, it may only be able to do so on or before the end of the Delisting Arrangement Period.** Upon completion of the delisting from SSE, TJ TROILA shares will be removed from the list of Special China Connect Securities and investors will no longer be allowed to buy or sell TJ TROILA shares through China Connect Service.

### Cessation of CCASS services after delisting

Pursuant to Rule 502 of the General Rules of CCASS (“CCASS Rules”), TJ TROILA shares will cease to be Eligible Securities after its delisting from SSE. HKSCC will thereafter cease to render services in respect of TJ TROILA shares pursuant to Rule 503 of the CCASS Rules.

As physical withdrawal of TJ TROILA shares from CCASS is not available, HKSCC will continue to hold TJ TROILA shares under a dummy Stock Code of 45721 for CCASS Participants in their Stock

Account after its delisting. Please note that as HKSCC will cease to provide the services contemplated under the CCASS Rules with respect to TJ TROILA shares after its delisting from SSE, notwithstanding any holding of TJ TROILA shares in a CCASS Participant's Stock Account, HKSCC shall have no obligation to notify CCASS Participants of any news with regarding to TJ TROILA or to act on any instruction or communication given or purported to be given with respect to any TJ TROILA share. In the worst case scenario, a CCASS Participant may never be able to exercise its rights and entitlements accruing to its TJ TROILA shares or to dispose of its TJ TROILA shares after the end of the Delisting Arrangement Period.

CCASS Participants are urged to consider the potential liquidity risk and other limitations as well as restrictions on holding TJ TROILA shares after the end of the Delisting Arrangement Period and promptly take all necessary actions where appropriate.
